2		("Nation") approved Cooperative Agreement L12AC20578 ("Cooperative
3		Agreement") between the United States Bureau of Land Management ("BLM")
4		and the Nation in order to fund undocumented migrant and smuggler trash
5		clean-up beginning on October 1, 2012 through September 30, 2017; and
6	WHEREAS,	the BLM, through amendment #004, amended the Cooperative Agreement to
7		provide an additional award to the Nation's Solid Waste Management Program
8		("SWMP") in the amount of \$20,000.00 to be expended by September 30, 2016; and
9	WHEREAS,	such funds are to be expended by the SWMP for the clean-up of undocumented
10		migrant and smuggler waste, including abandoned vehicles, all of which impact
11		the Nation within and along its borders; and
12	WHEREAS,	the SWMP was further notified by the BLM that there were unobligated funds
13		from the Cooperative Agreement in FY 2015 in the amount of \$16,209.81 and that
14		such amount was available for use by the SWMP; and
15	WHEREAS,	the SWMP has prepared a budget for FY 2016 which includes the newly awarded
16		amount of \$20,000.00 and the unobligated amount of \$16,209.81 for a total
17		budgeted amount of \$36,209.81 and such budget is attached hereto and
18		incorporated herein by this reference; and
19	WHEREAS,	the Agricultural and Natural Resources and the Budget and Finance Committees
20		of the Legislative Council have reviewed the attached budget and recommend its
21		approval.
