15		items 6510—Lodging, 6520—Per Diem, and 6600—Employee Tuition Aid, which
16		increase results from decreasing Indirect Costs; and
17	WHEREAS,	the Health and Human Services and the Budget and Finance Committees have
18		reviewed this budget amendment and recommend its approval.
