

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY16 Department of Health and Human Services Indian Health  
Service Office of Grants Management, Enhancing HIV/AIDS Screening and  
Patient Navigation Project, No. D921IHS0010-01-00 Budget Amendment #1)**

**RESOLUTION NO. 16-100**

1 **WHEREAS, the Tohono O'odham Nation ("Nation") submitted an application to the U.S.**  
2 **Department of Health and Human Services for the Enhancing HIV/AIDS**  
3 **Screening and Patient Navigation Project for funding in the amount of**  
4 **\$83,000.00 over the five year period from September 30, 2013 through August 31,**  
5 **2018; and**

6 **WHEREAS, the Nation was selected and received a Notice of Award dated September 27,**  
7 **2013, for an amount of \$28,108.00 for the first year of funding; and**

8 **WHEREAS, the FY 2016 budget of \$28,108.00 was approved by Tohono O'odham Legislative**  
9 **Council Resolution No. 15-178 for the third year funding period; and**

10 **WHEREAS, the Nation's Health and Human Services HIV/AIDS program received a new**  
11 **Notice of Award dated August 27, 2015, for the period of September 1, 2015 to**  
12 **August 31, 2016, in the amount of \$61,000.00, which will increase the budget by**  
13 **\$32,892.00; and**

14 **WHEREAS, the amendment #1 will create new line items for 7060 Food, 7220 GSA Vehicle**  
15 **Lease, 7230 Lease/Rentals, 7305 Liability Insurance, 7340 Public Relations, and**  
16 **7665 Client Support; and will decrease line items 7010 Program Supplies and**  
17 **7345 Consultants; and**

18 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**  
19 **reviewed this budget amendment and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
21 **approves the attached FY 2016 Department of Health and Human Services,**  
22 **Indian Health Service Office of Grants Management, Enhancing HIV/AIDS**  
23 **Screening and Patient Navigation Project Award No. D921IHS0010-01-00 Budget**  
24 **Amendment #1.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
26 **Chairperson of the Nation and any designated official to expend and administer**  
27 **the budget as attached, provided that any amendments affecting the funds or**  
28 **funding level be submitted for further prior approval by the Tohono O'odham**  
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
31 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
34 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
36 **June 18, 1934 (48 Stat.984).**
