5		billable services provided, and collecting third party reimbursements where
6		applicable for supplemental funding for the Home Health Program, among
7		other usages; and
8	WHEREAS,	pursuant to Legislative Council Resolution No. 98-501, the Division through the
9		Elder Health Care Initiative gained approval for the "establishment of a Speical
10		Revenue Fund for Home Health Reimbursement Revenues and budgeted
11		expenditures" and subsequently the Division has reconvened collecting third
12		party insurance such as Arizona Health Care Cost Containment Systems
13		(AHCCCS); and
14	WHEREAS,	the Division requests establishment of a revenue account for the accumulation
15		of third party revenue funds, to be utilized in further budgeting processes; and
16	WHEREAS,	a Community Health third party revenue budget for FY 2016 is attached; and
17	WHEREAS,	the Health and Human Services and the Budget and Finance Committees of the
18		Legislative Council have reviewed this budget and recommend its approval.
19	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
20		1. It hereby approves the establishment of a revenue account for
21		reimbursement revenues from appropriate eligible billable services
22		provided by the Division of Community Health Services.
23		2. The attached Tohono O'odham Department of Health and Human
24		Services – Division of Community Health Services FY 2016 Third Party
25		Revenue Budget in the amount of \$15,000.00 is hereby approved to
26		expend such funds.
27	BE IT FINALI	LY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
28		Chairperson and any designated official to expend and administer the budget as
29		attached, provided that any amendments affecting the funds or funding level is
30		submitted for further prior approval by the Tohono O'odham Legislative
