**RESOLUTION NO. 16-104**

1 **WHEREAS, Tohono O'odham Legislative Council approved Resolution 15-200 "Acceptance of**  
2 **the Brownfields Section 128(a) FY 2016 Budget" in the amount of \$145,000.00;**  
3 **and**

4 **WHEREAS, the Environmental Protection Office received the final grant award in the**  
5 **amount of \$140,650.00; and**

6 **WHEREAS, the Environmental Protection Office prepared a Budget Amendment increasing**  
7 **line items Salaries and Fringe and decreasing other line items per the attached**  
8 **budget; and**


9 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**  
10 **Council have reviewed this Budget and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **approves FY 2016 Brownfields Section 128(a) Budget Amendment #1 which**  
13 **reduces the budgeted amount of \$145,000.00 to a new amount \$140,650.00.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairperson and any designated official to expend and administer the budget as**  
16 **attached, provided that any amendmetns affecting the funds or funding level**  
17 **shall be submitted for further prior approval by the Tohono O'odham**  
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
20 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat.984).**
