

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District's Fiscal Year 2016 Budget Amendment #1 for
Sikol Himatk Community)**

RESOLUTION NO. 16-105

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized *"to manage any funds*
2 *within the exclusive control of the Tohono O'odham Nation...and to appropriate*
3 *these funds for the benefit of the nation and its members" provided that* (a) *All*
4 *expenditures of these funds shall be pursuant to appropriations or budgets"*
5 *authorized by resolution ordinance (Constitution of the Tohono O'odham*
6 *Nation, Article VI, Section 1(d)(d)); and*

7 **WHEREAS,** on February 20, 2016, the Gu Achi District Council approved a budget
8 amendment #1 for Sikol Himatk Community budget adding new line items #7000
9 - Office Supplies and #7676 - School Supplies; and

10 **WHEREAS,** the Tohono O'odham Legislative Council's Budget and Finance Committee did
11 review the attached budget and recommend its approval.


12 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council does hereby
13 approve the Gu Achi District's Fiscal Year 2016 Budget Amendment #1 for Sikol
14 Himatk Community as attached.

15 **BE IT FURTHER RESOLVED** that amendment #1 will add new line items 7000-office supplies
16 and 7676-School Supplies.

17 **BE IT FINALLY RESOLVED** that that the Tohono O'odham Legislative Council hereby authorizes
18 the Chairperson and any designated official to expend and administer the
19 budget as attached, provided that any amendments affecting the funds or
20 funding levels is submitted for further prior approval by the Tohono O'odham
21 Legislative Council.

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
23 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
