

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Tribal Law Enforcement Budget Amendment #2)**

RESOLUTION NO. 16-107

1 **WHEREAS, the Tohono O'odham Nation Police Department's FY 2016 Tribal Law**
2 **Enforcement budget was approved by Tohono O'odham Legislative Council**
3 **Resolution #15-165; and**

4 **WHEREAS, Budget Amendment #1 was approved by Tohono O'odham Legislative Council**
5 **Resolution #15-360; and**

6 **WHEREAS, the FY2016 Budget Amendment #2 was prepared in order to freeze three (3)**
7 **vacant positions: one (1) Bureau Chief, one (1) Financial Crimes Investigator,**
8 **and one (1) Program Manager, so that three (3) new positions could be created;**
9 **and**

10 **WHEREAS, the three (3) new positions include one (1) Police Sergeant and two (2) Police**
11 **Lientenants, which are needed to efficiently carry out the Department's duties;**
12 **and**

13 **WHEREAS, the amendment will reclassify the current position of Bureau Chief to Assistant**
14 **Chief of Police, all without increasing the Department's budget; and**

15 **WHEREAS, the Organizational Chart has been updated to reflect the changes; and**


16 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this**
17 **budget amendment and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves the attached FY 2016 Tribal Law Enforcement budget amendment #2.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level be**
23 **submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
26 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
