

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 638 Ranger Program Budget Amendment #1)**

RESOLUTION NO. 16-108

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Ranger Program FY 2016 budget was**
4 **approved by Legislative Council Resolution No. 15-167; and**

5 **WHEREAS, the FY 2016 Budget Amendment #1 reclassifies two (2) Ranger positions as**
6 **Ranger, Senior positions, and also creates a new line item: 7075 Fuel, all without**
7 **affecting the total budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this**
9 **budget amendment and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **approves the attached FY 2016 638 Ranger Program budget amendment #1.**

12 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
13 **Chairman and any designated official to expend and administer the budget as**
14 **attached, provided that any amendments affecting the funds or funding level**
15 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
16 **Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
18 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
23 **June 18, 1934 (48 Stat.984).**
