

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2016 Mining Royalties Distribution Budget)**

RESOLUTION NO. 16-110

1 **WHEREAS, the Tohono O'odham Legislative Council, Resolution No.16-017, Approved**
2 **Apportionment of Mining Royalties by Equal Distribution, and whereby, San**
3 **Lucy District was allocated \$115,253.30 and said funds are available for**
4 **expenditures subject to budgets approved in accordance with Article VI, Section**
5 **1(d)(2) and Article IX, Section 7 of the Tohono O'odham Nation Constitution; and**

6 **WHEREAS, the San Lucy District Council passed Resolution No. SL 03-24-16, approving the**
7 **Mining Royalties Distribution Budget, in the amount of \$115,253.30 detailing**
8 **intended use of funds, in the best interest of San Lucy District; and**

9 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee have**
10 **reviewed the attached budget and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
12 **San Lucy District FY 2016 Mining Royalties Distribution Budget as attached in**
13 **the amount of \$115,253.30.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the San**
15 **Lucy District Chairperson and any other designated District Official to expend**
16 **an administer the budget as attached, provided that any**
17 **amendments/modifications affecting the funds or funding level shall be**
18 **submitted for further prior approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
21 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
