6		2016, however, the Nation successfully petitioned for the tolling of the
7		expiration date until such time that the Republic of Mexico concurs with the
8	:	construction permit; and
9	WHEREAS,	upon concurrence from Mexico, the Nation shall have 18 months to complete the
10		construction of KWAK-LP; and
11	WHEREAS,	Hewel Ni'ok management has prepared the attached budget which provides
12		funds for the purchase of equipment and construction of KWAK-LP FM radio
13	:	station; and
14	WHEREAS,	the Cultural Preservation and Budget and Finance Committees of the Legislative
15		Council has reviewed this budget and recommends its approval.
16	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
17		approves and authorizes an appropriation from the general fund surplus for FY
18		2016 San Xavier KWAK-LP Radio Project in the amount of \$603,817.97 as
