

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY16 General Support Services/Facility Management Program Budget
Amendment No. 1)**

RESOLUTION NO. 16-118

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to adopt, approve and amend annual budgets and to authorize**
3 **the expenditure of funds in accordance with these budgets." (Constitution,**
4 **Article VI, Section 1(d)(3)); and**

5 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2016 General Support**
6 **Services (GSS)/Facility Management Program budget, in the amount of**
7 **\$1,300,722.32 through Resolution No. 15-165; and**

8 **WHEREAS, the GSS/Facility Management Program has prepared and submitted for**
9 **approval FY 2016 Budget Amendment No. 1 to create line items 6500-Training**
10 **Fees and Registration, 6510-Lodging, 6520-Per Diem, and 6530-Transportation**
11 **and to decrease line item 7420-RM Buildings ; and**

12 **WHEREAS, The Budget and Finance Committee of the Legislative Council has reviewed this**
13 **budget and recommends its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the FY 2016 GSS/Facility Management Program Budget Amendment**
16 **No. 1 which does not change the original base amount of \$1,300,722.32.**

17 **BE IT FURTHER RESOLVED that Amendment No. 1 will create line items 6500-Training and**
18 **Registration, 6510-Lodging, 6520-Per Diem, and 6530-Transportation and**
19 **decrease line item 7420-RM Buildings.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget,**
22 **as attached, provided that any amendment affecting the funds or funding level**
23 **is submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
26 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
