

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Tohono O'odham Legislative Council Calendar June 2016 - June 2017)**

LEGISLATIVE ORDER NO. 16-127

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish**
2 **rules and procedures to regulate all meetings of the Tohono O'odham Council"**
3 **pursuant to Section 1(a) of Article VI of the Constitution of the Tohono O'odham**
4 **Nation; and**

5 **WHEREAS, the Legislative Council has adopted Legislative Rules requiring that, "Prior to an**
6 **official adjournment, the Legislative Council shall adopt a legislative calendar**
7 **which shall commence on the first working day of June on which the Legislative**
8 **Council shall be called into legislative session" (Legislative Rules of the**
9 **Tohono O'odham Legislative Council, Article I, Section 1(A)(1)); and**

10 **WHEREAS, in accordance with the Legislative Rules, the Legislative Rules Committee has**
11 **drafted the "Tohono O'odham Legislative Council Calendar June 2016 - June**
12 **2017" and recommends its adoption.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that**
14 **notwithstanding Article I, Section 1(A)(1) of the Legislative Rules, the "Tohono**
15 **O'odham Legislative Council Calendar June 2016 - June 2017" is adopted.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04TH day of**
17 **APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
19 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
21 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat.984).**
