(Approving the FY 2016 Department of Health and Human Services, Division of
Senior Services Budget Amendment #1)

RESOLUTION NO. 16-128

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Division of Senior**
2 **Services' FY 2016 budget by Resolution No. 15-165 in the amount of \$653,945.00;**
3 **and**

4 **WHEREAS, the FY 2016 Budget Amendment #1 will increase salary and fringe benefit line**
5 **items to allocate cost shares needed for employees by decreasing line items 7005-**
6 **Office Equipment, 7010-Program Supplies, and 7075-Fuel; and**

7 **WHEREAS, the total overall budgeted amount will remain the same; and**


8 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
9 **Legislative Council have reviewed this budget amendment #1 and recommend its**
10 **approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approves the attached FY 2016 Department of Health and Human Services,**
13 **Division of Senior Services Budget Amendment #1.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairperson and any designated official to expend and administer the budget as**
16 **attached, provided that any budget amendments affecting the funds or funding**
17 **levels be submitted for further prior approval by the Tohono O'odham Legislative**
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
20 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat.984).**
