

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2016 Tribal Employment Rights Office Administration**  
**West Valley Resort Budget Amendment #1)**

**RESOLUTION NO. 16-129**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2016 Tribal**  
2 **Employment Rights Office Administration West Valley Resort Budget in the**  
3 **amount of \$278,456.46 by Resolution No. 15-335; and**

4 **WHEREAS, the continued goal of the Tribal Employment Rights Office, TERO of the Tohono**  
5 **O'odham Nation, Nation is to increase employment of Indians on and near the**  
6 **Nation by enforcing Indian Preference in employment, training, contracting,**  
7 **sub-contracting and to eradicate employment discrimination within the exterior**  
8 **boundaries of the Nation; and**

9 **WHEREAS, TERO prepared and submitted for review and approval the attached FY 2016**  
10 **Tribal Employment Rights Office Administration West Valley Resort Budget**  
11 **Amendment #1; and**

12 **WHEREAS, the FY 2016 Budget Amendment #1 will adjust the Operational Expense line items**  
13 **and create line items 6530 Transportation and 7355 Professional Services while**  
14 **making no change to the original budget amount of \$278,456.46 from the TERO**  
15 **Commission Revenue Fund; and**

16 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
17 **the Legislative Council reviewed the FY 2016 Budget Amendment #1 and**  
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2016 Tribal Employment Rights Office Administration West Valley Resort**  
21 **Budget Amendment #1 to adjust the Operational Expense line items and create**  
22 **line items 6530 Transportation and 7355 Professional Services while making no**  
23 **change to the original budget amount of \$278,456.46 from the TERO Commission**  
24 **Revenue Fund.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget, as**  
27 **attached, provided that any amendments affecting the funds or funding level**  
28 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
29 **Council.**






