7	WHEREAS,	in 1891, 41,000 acres within the San Xavier Reservation were allotted in trust to
8		individual Indians under the General Allotment Act of 1887 ("Dawes Act"); and
9	WHEREAS,	since 1937, the San Xavier District has been recognized as one of the 11 districts
10		of the Nation (Constitution and By-Laws of the Papago Tribe, Article VI, Section 1
11		(1937); Constitution of the Tohono O'odham Nation, Article IX, Section 1 (1986));
12		and
13	WHEREAS,	the Nation owns fractionated interests in numerous allotments in the San
14		Xavier District; and
15	WHEREAS,	25 C.F.R. Part 162.012 sets out the requirements for consent of owners of
16		fractionated interests in Indian lands; and
17	WHEREAS,	in order to expedite the consent procedures set out in 25 C.F.R. Part 162.012 for
18		allottees pursuing commercial or homesite leases on Indian lands in which the
19		Nation owns a fractionated interest of less than 10%, the Nation has developed
20		the attached process; and
21	WHEREAS,	the Agricultural and Natural Resources and Housing Committees recommend
22		approval by the Legislative Council.
23	NOW, THER	EFORE, BE IT RESOLVED the Tohono O'odham Legislative Council enacts the
24		Nation's Consent to Commercial Leases and Home Sites Allotments as Tohono
