9		Code Chapter 3); and		
10	WHEREAS,	the U.S. Department of Veterans Affairs issued a March 3, 2016 notice of tribal		
11		consultation for a proposed rule change to 38 CFR Part 14 to allow for the		
12		recognition of tribal organizations for representation of Veterans Affairs		
13		claimants; and		
14	WHEREAS,	the Nation's Veterans Affairs Office, which was established in 1999 to provide		
15		veterans resources and assistance to the services provided by the U.S.		
16		Department of Veterans Affairs, supports the proposed rule change to 38 CFR		
17		Part 14 to recognize tribal organizations (Federal Register, Vol. 81, No. 47); and		
18	WHEREAS,	the Human Resources Development Committee drafted and reviewed the		
19		Nation's written comments, which are incorporated by this reference in		
20		substantially the form attached, and recommends approval and submission to		
21		the U.S. Department of Veterans Affairs prior to the April 11, 2016 deadline.		
22	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it			
23		approves the Nation's written comments in substantially the form attached for		
24		submission by the Nation's chairperson to the U.S. Department of Veterans		
25		Affairs prior to the April 11, 2016 deadline.
