

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Pisinemo District Operations FY 2016 Budget Amendment #1)**

**RESOLUTION NO. 16-133**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 15-325 approved the FY**  
2 **2016 District Allocation and Apportionment of Gaming Revenue to Districts by**  
3 **Equal Distribution in the amount of \$1,615,811.13 to each of the eleven Districts**  
4 **of the Tohono O'odham Nation; and**

5 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-378 approved the FY2016**  
6 **Pisinemo District Budget in the amount of \$1,615,811.13; and**

7 **WHEREAS, at a special meeting of the Pisinemo District Council held on Tuesday, February**  
8 **23, 2016 the District Council reviewed and approved the proposed budget**  
9 **amendment by Resolution No. 16-P-13; and**

10 **WHEREAS, amendment #1 will either negatively or positively affect the amounts for each of**  
11 **the following line items 610 Salaries, 621 Bonus, 720 Office Supplies, 727**  
12 **Materials, 771 R/M Vehicles, 772 R/M Buildings, 810 Professional Services, and**  
13 **812 Public Relations; and**

14 **WHEREAS, the amendments were made to cover anticipated expenses within each of the**  
15 **line items for the remainder of the fiscal year and does not change the original**  
16 **base amount of \$1,615,811.13 for Pisinemo District; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the attached budget and**  
18 **recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **approves the Pisinemo District Operations Budget FY 2016 Budget Amendment**  
21 **#1 as attached.**


22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
23 **the District Chairperson and any designated official to expend and administer**  
24 **the budget as attached provided that any amendments/modification affecting**  
25 **the funds or funding levels of the budget shall be submitted to the Tohono**  
26 **O'odham Legislative Council for further prior approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
28 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and 180.6[04] ABSENT, pursuant to the powers vested in the Council**  
30 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**




