

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Pisinemo District Mining Royalties FY 2016 Budget)**

**RESOLUTION NO. 16-136**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 16-017 approved the FY**  
2 **2016 Mining Royalties to Districts by Equal Distribution in the amount of**  
3 **\$115,253.30 to each of the eleven Districts of the Tohono O'odham Nation; and**

4 **WHEREAS, Pisinemo District Council reviewed and approved the proposed budget by**  
5 **Resolution No. 16-P-14; and**

6 **WHEREAS, the Pisinemo District Council approved that each of the communities get a share**  
7 **of \$10,000.00 each totaling \$40,000.00 and the remainder will be part of the**  
8 **Pisinemo District Operations supplement totaling \$75,253.30; and**


9 **WHEREAS, the Budget and Finance Committee has reviewed the attached budget and**  
10 **recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **approves the Pisinemo District Mining Royalties Budget FY 2016 as attached.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
14 **the District Chairperson and any designated official to expend and administer**  
15 **the budget as attached provided that any amendments/modification affecting**  
16 **the funds or funding levels of the budget shall be submitted to the Tohono**  
17 **O'odham Legislative Council for further prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
19 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 180.6[05] ABSENT, pursuant to the powers vested in the Council**  
21 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
24 **June 18, 1934 (48 Stat.984).**


