2 **Approving Chukut Kuk District FY 2016 Budget; and**

3 **WHEREAS, Amendment No. 1 to the Chukut Kuk District FY 2016 budget was approved by**
4 **Tohono O'odham Legislative Council Resolution No. 15-480; and**

5 **WHEREAS, Amendment No. 2 to the Chukut Kuk District FY 2016 budget was approved by**
6 **Tohono O'odham Legislative Council Resolution No. 16-020; and**

7 **WHEREAS the Chukut Kuk District Council enacted Resolution No. 2016-08 approving**
8 **Vamori Community FY 2016 Budget Amendment No. 2 transferring funds in the**
9 **amount of \$3,200.00 to various line items to cover anticipated costs; and**


10 **WHEREAS, the Legislative Council Budget and Finance Committee did review Vamori**
11 **Community FY 2016 Budget Amendment No. 2 and recommends its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves Chukut Kuk District-Vamori Community FY 2016 Budget Amendment**
14 **No. 2.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **District Chairperson and any designated official to expend and administer the**
17 **budget as attached provided that any amendments affecting the funds or**
18 **funding level of the Chukut Kuk District FY 2016 Budget shall be submitted to**
19 **the Tohono O'odham Legislative Council for prior approval.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
21 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 180.6[05] ABSENT, pursuant to the powers vested in the Council**
23 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**


