

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting April 15, 2016 Special Session for Presentation of the Pisinemo
District Master Lease)

DEFEATED
LEGISLATIVE ORDER NO. 16-139

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council
6 with the authority to "by majority vote, call for a special session" (Legislative
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 **WHEREAS,** the Agricultural and Natural Resources Committee has requested a special
9 session on April 15, 2016 for the presentation of the Pisinemo District Master
10 Lease.

11 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a
12 special session on April 15, 2016 for the presentation of the Pisinemo District
13 Master Lease.

14 The foregoing Order was defeated by the Tohono O'odham Legislative Council on the 06TH day of
15 APRIL, 2016 at a meeting at which a quorum was present with a vote of 1,358.3 FOR; 1,482.5
16 AGAINST; [01] NOT VOTING and 180.6[04] ABSENT, pursuant to the powers vested in the Council
17 by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
18 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat.984).
