BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairperson is authorized to execute the Agreement, provided that any amendments affecting the funds or funding level shall be submitted for further prior approval by the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06th day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-AGAINST; -0- NOT VOTING; and 180,6[04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3)and(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
