

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2016 Sif-Oidak District Administration Budget Amendment #1)**

**RESOLUTION NO. 16-142**

1 **WHEREAS, the Tohono O'odham Legislative Council on August 07<sup>th</sup>, 2015, passed Resolution**  
2 **No. 15-325, "Approving FY 2016 District Allocation and Apportionment of Gaming**  
3 **Revenues to Districts by Equal Distribution; and**

4 **WHEREAS, the Sif- Oidak District Council, passed Resolution No. SODC 15-158 on September**  
5 **12, 2015, "Approving the FY 2016 Sif-Oidak District Budget in the amount**  
6 **\$1,615,811.13"; and**

7 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC 16-039 on March 19,**  
8 **2016, "Approving the FY 2016 Sif-Oidak District Administration Budget**  
9 **Amendment #1 in the amount of \$7,097.00"; and**

10 **WHEREAS, Amendment #1 is adding \$7,097.00 into line items (622) Fringe - \$6,097.00 and**  
11 **(770) R&M Equipment - \$1,000.00 by decreasing line Items (624) Bonus -**  
12 **\$1,619.83, (751) Leases & Rentals - \$3,000.00 and (772) R&M Equipment -**  
13 **\$2,477.17 to cover additional expenditures for the remainder of the Fiscal Year;**  
14 **and**

15 **WHEREAS, the Budget and Finance Committee did review the FY 2016 Sif-Oidak District**  
16 **Administration Budget Amendment #1 and recommends approval.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council, that it does**  
18 **hereby approve the FY 2016 Sif-Oidak District Administration Budget**  
19 **Amendment #1 as attached.**

20 **BE IT FURTHER RESOLVED that Amendment #1 does not reflect any changes to the overall**  
21 **budgeted amount.**


22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **District Chairperson and any designated official to expend and administer the**  
24 **budget, provided that any modifications or amendments shall be submitted for**  
25 **prior approval by the Tohono O'odham legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
27 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**


