

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District's Fiscal Year 2016 Budget Amendment #1 for
Covered Wells Community)**

RESOLUTION NO. 16-143

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized *"to manage any funds*
2 *within the exclusive control of the Tohono O'odham Nation...and to appropriate*
3 *these funds for the benefit of the nation and its members" provided that* (a) *All*
4 *expenditures of these funds shall be pursuant to appropriations or budgets"*
5 *authorized by resolution ordinance (Constitution of the Tohono O'odham*
6 *Nation, Article VI, Section 1(d)(3)); and*

7 **WHEREAS,** the Gu Achi District Council approved a budget amendment for Covered Wells
8 **Community** by amending the budget justification for line item #7060 - FOOD
9 **adding new language; and**

10 **WHEREAS,** the Tohono O'odham Legislative Council's Budget and Finance Committee did
11 **review the attached budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council does hereby
13 **approve the Gu Achi District's Fiscal Year 2016 Budget Amendment #1 for**
14 **Covered Wells Community as attached.**

15 **BE IT FINALLY RESOLVED** that that the Tohono O'odham Legislative Council hereby authorizes
16 **the Chairperson and any designated official to expend and administer the**
17 **budget as attached, provided that any amendments affecting the funds or**
18 **funding levels is submitted for further prior approval by the Tohono O'odham**
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
21 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
