1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-325 approved the FY 2016**
2 **budget for Sells District and its Communities and amended by Resolution No. 15-**
3 **405; and**

4 **WHEREAS, Sells Community has identified the need to request for additional funding to**
5 **continue meeting their FY 2016 budget goals by preparing and acquiring**
6 **approvals for the attached budget amendment No. 1 and its justifications with**
7 **Sells Community Resolution No. SC-065-16 and Sells District Council Resolutions**
8 **No. SD-18-16 and SD-19-16; and**

9 **WHEREAS, Sells Community Budget Amendment No. 1 will increase line items: 6500 Tuition**
10 **& Registration, 6510 Lodging, 6520 Per Diem, 6530 Transportation/Travel, 7035**
11 **Building Materials, 7340 Public Relations, 7355 Professional Services, 7610**
12 **Clothing Allowance, 7615 Donation/Contributions, 7625 General Assistance, 7675**
13 **Scholarship and Tuition; and**

14 **WHEREAS, the additional amount of \$104,500.00 being requested by Sells Community will**
15 **come from Sells District Administration Budget Line item 7620 Miscellaneous**
16 **Assistance and has been granted by FY 2016 Sells District Administration Budget**
17 **Amendment No. 2 approved by Resolution No. SD-19-16; and**

18 **WHEREAS, per the Tohono O'odham Legislative Council, corrections were made to the**
19 **justifications for FY 2016 Sells Community budget amendment No. 1 and**
20 **resubmitted through the budget process and approved with Sells Community**
21 **Resolution No. SC-090-16 and Sells District Council Resolution No. SD-33-16; and**

22 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
23 **did review Sells Community Budget Amendment No. 1 and Sells District**
24 **Administration Budget Amendment No. 2 and recommends its approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**
26 **2016 Budget Amendment No. 2 for Sells District Administration and FY2016**
27 **Budget Amendment No. 1 for Sells Community, transferring \$104,500.00 from**
28 **Administration Budget Line Item #7620 Miscellaneous Assistance to Sells**
29 **Community Budget.**

30 **BE IT FURTHER RESOLVED that amendment No. 1 increases Sells Community FY 2016 Budget**
31 **from \$85,000.00 to \$189,500.00 and Amendment No. 2 decreases Sells District**
32 **Administration Budget from \$1,275,811.13 to \$1,171,311.13 but does not affect the**
33 **overall Sells District budgeted amount of \$1,615,811.13.**

34 **BE IT FINALLY RESOLVED that that the Tohono O'odham Legislative Council hereby authorizes**
35 **the Sells District Chairperson and any designated official to expend and**






