

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution 99-059 "Approving a Process for Grant Fund Applications by
the Executive Branch" to Include Notification of the Appropriations Committee)**

RESOLUTION NO. 16-149

1 **WHEREAS, the Nation's Constitution vests the Legislative Council with the authority "to**
2 **promote, protect and provide for public health, peace, morals, education and**
3 **general welfare of the Tohono O'odham Nation and its members" and to "consult,**
4 **negotiate and conclude agreements and contracts on behalf of the Tohono**
5 **O'odham Nation with Federal, State and local governments and other Indian**
6 **tribes or their departments, agencies, or political subdivisions. . ." (Constitution,**
7 **Article VI, Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, Resolution No. 99-059 established the process by which Executive Branch**
9 **departments identify and submit grant fund applications, and specifies the level**
10 **of review required at each stage of the process; and**

11 **WHEREAS, the Appropriations Committee is responsible for oversight of any "activity of the**
12 **Nation, its enterprises or entities which relates to the appropriations process,**
13 **establishing the Nation's priorities before the United States Congress, members**
14 **of Congress and Congressional staff" and also directs the Nation's federal lobbyist**
15 **to assist with appropriations requests (Appropriations Committee Plan of**
16 **Operations); and**

17 **WHEREAS, in recent years with the end of earmarked funds in federal appropriations bills,**
18 **the focus for acquiring federal funds has shifted significantly to grant fund**
19 **applications; and**

20 **WHEREAS, the Appropriations Committee recommends an amendment to the Process for**
21 **Grant Fund Applications by the Executive Branch, dated April 2016 for reference**
22 **and which is incorporated by this reference, which will keep the Committee**
23 **apprised of Executive Branch departments grant applications.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it amends**
25 **Resolution No. 99-059 to adopt the April 2016 amendment to the Process for Grant**
26 **Fund Applications.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
28 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(c)(2)and(f) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
