8	WHEREAS,	the Water Resource Department is requesting a budget amendment #1 to freeze
9		the vacant Hydrology Technician position, effective February 5, 2016; and
10	WHEREAS,	the Water Resources Department is also requesting to decrease the Salary and
11		Fringe Benefit line items by \$65,307.00 and increase the Professional Service line
12		item by \$65,307.00; and
13	WHEREAS,	there will be no change to the total budget amount; and
14	WHEREAS,	the Water Resources and the Budget and Finance Committees of the Tohono
15		O'odham Legislative Council have reviewed this budget amendment #1 and
16		recommend its approval.
17	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
18		approves Budget Amendment #1 to the Water Resources Department FY 16
