

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Planning and Economic Development Department
Administration Budget Amendment No. 1)

RESOLUTION NO. 16-151

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 the Planning and Economic Development Department**
8 **Administration Budget in the amount of \$866,693.60 was approved by Resolution**
9 **No. 15-165; and**

10 **WHEREAS, the Planning and Economic Development Department has prepared and**
11 **submitted for review and approval its FY 2016 Budget Amendment No. 1, which is**
12 **incorporated by this reference and which (1) creates line items 6500 Training Fees**
13 **and Registration, 6510 Lodging, 6520 Per Diem, 6530 Transportation, and 7060**
14 **Food; and (2) decreases line items 7010 Program Supplies, 7075 Fuel, 7355**
15 **Professional Services and 7420 RM Building; and**

16 **WHEREAS, the FY 2016 Planning and Economic Development Department Administration**
17 **Budget Amendment No. 1 will not change the budget amount approved by**
18 **Resolution No. 15-165; and**

19 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2016**
20 **Planning and Economic Development Department Administration Budget**
21 **Amendment No. 1 and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2016 Planning and Economic Development Department Administration**
24 **Budget Amendment No. 1.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designed official is authorized to administer and**
27 **expend the FY 2016 Planning and Economic Development Department**
28 **Administration Budget as amended, provided however, that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
32 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
33 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
34 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
35 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
36 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
37 **18, 1934 (48 Stat.984).**


