

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Legislative Branch Budget Amendment No. 2)**

RESOLUTION NO. 16-157

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**
2 **control of the Tohono O’odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members” provided that “[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets” authorized by resolution**
5 **or ordinance (Constitution of the Tohono O’odham Nation, Article VI, Section**
6 **1(d)(2)); and**

7 **WHEREAS, the Legislative Branch FY 2016 budget was approved by Resolution No. 15-166;**
8 **and**

9 **WHEREAS, the Legislative Branch administration has prepared and submitted for review**
10 **and approval of its FY 2016 Budget Amendment No. 2, which is incorporated by**
11 **this reference and which (1) reduces expenses in 6000 Salaries, 6005 Occasional**
12 **Appointment, 6010 Leave, 6110 FICA, 6120 Workers Comp, and 6240 Employer**
13 **Matching 401K; and (2) increases line items 6230 Employer Long Term Disability,**
14 **6235 Employer Short Term Disability, 6510 Lodging, 7000 Supplies – Office, 7060**
15 **Food, 7340 Public Relations, 7355 Professional Services, 7365 Committee Fees**
16 **and 7615 Donation/Contribution; and**

17 **WHEREAS, FY 2016 Legislative Branch Budget Amendment No. 2 will not increase the**
18 **amount of funds originally appropriated to Legislative Branch FY 2016 Budget;**
19 **and**

20 **WHEREAS, the FY 2016 Legislative Branch Budget Amendment No. 2 has been reviewed and**
21 **recommends approval by the Budget and Finance Committee.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council approves the**
23 **FY 2016 Legislative Branch Budget Amendment No. 2 effective on the date of this**
24 **resolution.**

25 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council Chairperson and Vice-**
26 **Chairperson are authorized to administer the FY 2016 Legislative Branch**
27 **Budget as amended, provided however, that any amendments affecting these**
28 **funds or funding levels budgeted shall be submitted for prior approval by the**
29 **Tohono O’odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 19TH**
31 **day of APRIL, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O’odham Nation, adopted by**
34 **the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
36 **June 18, 1934 (48 Stat.984).**


