8		applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and
9	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12		date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications incorrectly listed the enrollment
15		numbers of members; and
16	WHEREAS,	the Enrollment Program recommends that Resolution No. 2000-223 be amended
17		to reflect the correct enrollment number for the member identified in the May
18		2016 Corrected Enrollment Resolution Summary, which is incorporated by this
19		reference.
20	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution
21		No. 2000-223 is amended upon the effective date of the resolution to reflect the
22		correct enrollment number for the member identified in the May 2016 Corrected
