

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Department of Health and Human Services, Division of Family Assistance**  
**- FY2017 Low Income Home Energy Assistance Program Budget)**

**RESOLUTION NO. 16-171**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "to adopt, approve and amend annual budgets and to authorize the**  
3 **expenditure of funds in accordance with these budgets." (Constitution, Article VI,**  
4 **Section 1(d)(3)); and**

5 **WHEREAS, the Low Income Home Energy Assistance Program ("LIHEAP") has been beneficial**  
6 **in providing financial assistance to eligible low-income households in meeting**  
7 **utility needs; and**

8 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2017 through the State of**  
9 **Arizona, Department of Economic Security, Division of Aging and Adult Services -**  
10 **Community Action Program is \$62,572.00; and**

11 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services, Division**  
12 **of Family Assistance is submitting the FY2017 budget for funding through the**  
13 **State of Arizona, Department of Economic Security, Division of Aging and Adult**  
14 **Services - Community Action Program in the amount of \$62,572.00 for contract**  
15 **period July 01, 2016 through June 30, 2017; and**

16 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
17 **Legislative Council have reviewed this budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
19 **authorizes the expenditure of the FY2017 LIHEAP budget in the amount of**  
20 **\$62,572.00 in accordance with the attached budget and to utilize the Nation's**  
21 **resources pending reimbursement from the Grantor for the continuation of this**  
22 **Grant.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level is**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


