

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2016 Department of Health and Human Services, Division of  
Child Welfare Title IV-B, Subparts 1 and 2 Carry Forward Budgets)**

**RESOLUTION NO. 16-172**

1 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare Title IV-**  
2 **B, Subparts 1 (Stephanie Tubb Jones Fund for Child Welfare Services) and 2**  
3 **(Promoting Safe and Stable Families) budgets for the grant period beginning**  
4 **October 1, 2014 and ending September 30, 2016 were approved by Legislative**  
5 **Council Resolution No. 14-356; and**

6 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare has**  
7 **\$44,059.00 remaining of the Title IV-B, Subpart 1 award and \$45,095.00 remaining**  
8 **in Title IV-B, Subpart 2 award, and the entire grant award must be expended by**  
9 **September 30, 2016; and**

10 **WHEREAS, the carry forward budgets identify the P.L. 93-638 master contract; specifically,**  
11 **the BIA Social Services budget for child welfare services and the BIA ICWA budget**  
12 **for Family Preservation Program as the source of the Title IV-B, Subparts 1 and 2**  
13 **required 25% match; and**

14 **WHEREAS, the carry forward budgets reflect the 10% administrative cost limitation imposed**  
15 **by the U.S. Department of Health and Human Services, Administration for**  
16 **Children and Families for Title IV-B budgets; and**

17 **WHEREAS, the carry forward budgets will be used for operational expenses; and**

18 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
19 **Legislative Council have reviewed these budgets and recommend their approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
21 **approves the FY 2016 Department of Health and Human Services, Division of**  
22 **Child Welfare Title IV-B, Subparts 1 and 2 carry forward budgets in the amounts**  
23 **of \$44,059.00 and \$45,095.00, respectively.**

24 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**  
25 **P.L. 93-638 master contract; specifically, the BIA Social Services budget for child**  
26 **welfare services the BIA ICWA budget for Family Preservation Program as the**  
27 **source of the Title IV-B, Subparts 1 and 2 required 25% match; and also approves**  
28 **the 10% administrative costs limitation contained in the carry forward budgets.**

4 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**

10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
11 **18, 1934 (48 Stat.984).**
