

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the FY 2016 Attorney Contract with Sonosky,
Chambers, Sachse, Miller and Munson, LLP)**

RESOLUTION NO. 16-175

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "employ legal counsel for the protection and advancement of**
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, by Resolution No. 15-427 the Tohono O'odham Nation ("Nation") approved an**
6 **Attorney Contract with the law firm of Sonosky, Chambers, Sachse, Miller and**
7 **Munson, LLP, funded by the FY 2016 Office of Attorney General Budget; and**

8 **WHEREAS, by Resolution No. 16-116 the Tohono O'odham Legislative Council approved the**
9 **FY 2016 Office of Attorney General Budget Amendment No. 2, which increased**
10 **line item 7355 – Professional Services to assist with the self-governance**
11 **compacting efforts; and**

12 **WHEREAS, Amendment No. 1 to the Attorney Contract with the law firm of Sonosky,**
13 **Chambers, Sachse, Miller and Munson, LLP will increase the budget for the**
14 **contract from \$185,000.00 to \$476,535.00, an increase of \$291,535.00; and**

15 **WHEREAS, the Domestic Affairs Committee has reviewed Amendment No. 1 to the Attorney**
16 **Contract with the law firm of Sonosky, Chambers, Sachse, Miller and Munson,**
17 **LLP and recommends approval by the Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **Amendment No. 1 to the Attorney Contract with the law firm of Sonosky,**
20 **Chambers, Sachse, Miller and Munson, LLP for FY 2016 in substantially the form**
21 **attached and authorizes the Chairperson of the Nation to execute it.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
23 **day of MAY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;-0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Sections 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**




