

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Choulic Community FY 2016 Budget Amendment No. 2)

RESOLUTION NO. 16-178

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation and to appropriate**
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, Choulic Community Budget Amendment #2 will decrease line item # 7035 --**
8 **Building Materials, also increases line item # 7410 - RM Vehicles and includes**
9 **additional language to the following line items # 6500 - Training Fees and**
10 **Registrations, Line Item # 7010 - Program Supplies, Line Item # 7110 --**
11 **Communication Expense and Line Item 7620 - Miscellaneous Assistance; and**

12 **WHEREAS, amendment #2 will not affect Choulic Community's FY 2016 current budget in the**
13 **amount of \$213,214.75, nor will it affect the overall Baboquivari District FY 2016**
14 **budget in the amount of \$2,154,346.58.**

15 **WHEREAS, the Budget and Finance Committee have reviewed Choulic Community FY 2016**
16 **Budget Amendment No. 2 and recommend its approval.**


17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **Choulic Community FY 2016 Budget Amendment No. 2 as attached.**

19 **BE IT FURTHER RESOLVED amendment #2 will not affect current Choulic Community FY 2016**
20 **budget of \$213,214.75, nor will it affect the overall Baboquivari District FY 2016**
21 **budget in the amount of \$2,154,346.58.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **District Chairperson and any designated official to expend and administer the**
24 **budget, provided that any modifications or amendments shall be submitted for**
25 **prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
27 **day of MAY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Sections 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**


