

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Fresno Canyon Community FY 2016 Budget Amendment #1)**

**RESOLUTION NO. 16-179**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2); and**

7 **WHEREAS, Fresno Canyon Community Budget Amendment #1 will correct salaries for 2**  
8 **community workers positions to be retro from October 01, 2015, decreasing line**  
9 **items 6510 Lodging, 6520 - Per Diem, increasing line items 6010 - Leave, 6110 -**  
10 **FICA, 6120 - Workers Comp, 6230 - Employer Long Term Disability and 6234 -**  
11 **Employer Short Term Disability; and**

12 **WHEREAS, amendment #1 will not affect Fresno Canyon Community's FY 2016 current**  
13 **budget in the amount of \$239,535.54, nor will it affect the overall Baboquivari**  
14 **District FY 2016 budget in the amount of \$2,154,346.58.**

15 **WHEREAS, the Budget and Finance Committee of the Tohono Legislative Council has**  
16 **reviewed the FY 2016 Budget Amendment #1 for Fresno Canyon Community and**  
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
19 **Fresno Canyon Community FY 2016 Budget Amendment #1 as attached.**

20 **BE IT FURTHER RESOLVED amendment #1 will not affect current Fresno Canyon Community**  
21 **FY 2016 budget of \$239,535.54, nor will it affect the overall Baboquivari District FY**  
22 **2016 budget in the amount of \$2,154,346.58.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **District Chairperson and any designated official to expend and administer the**  
25 **budget, provided that any modifications or amendments shall be submitted for**  
26 **prior approval by the Tohono O'odham Legislative Council.**

7 18, 1934 (48 Stat.984).
