10		FICA, 6120 - Workers Comp, 6230 - Employer Long Term Disability and 6234 -
11		Employer Short Term Disability; and
12	WHEREAS,	amendment #1 will not affect Fresnal Canyon Community's FY 2016 current
13		budget in the amount of \$239,535.54, nor will it affect the overall Baboquivari
14		District FY 2016 budget in the amount of \$2,154,346.58.
15	WHEREAS,	the Budget and Finance Committee of the Tohono Legislative Council has
16		reviewed the FY 2016 Budget Amendment #1 for Fresnal Canyon Community and
17		recommend its approval.
