

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2016 Sif Oidak District Senior Services Budget Amendment #1)**

**RESOLUTION NO. 16-180**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the Nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the Sif Oidak District Council, passed Resolution No. SODC 16-050 on April 23,**  
8 **2016, "Approving the FY 2016 Sif Oidak District Senior Services Budget**  
9 **Amendment #1 in the amount of \$4,700.00"; and**

10 **WHEREAS, amendment #1 will increase line item 610.1-Leave, 760-Travel Expense and will**  
11 **decrease 630-Insurance, 650-Tuition and Registration, 712-Gas, Oil and**  
12 **Coolants and 850-Consumables to cover additional expenditures for the**  
13 **remainder of the Fiscal Year; and**

14 **WHEREAS, the Budget and Finance Committee did review the FY 2016 Sif Oidak District**  
15 **Senior Services Budget Amendment #1 and recommends approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**  
17 **2016 Sif Oidak District Senior Services Budget Amendment #1 as attached.**

18 **BE IT FURTHER RESOLVED amendment #1 does not reflect any changes to the overall**  
19 **budgeted amount.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **District Chairperson and any designated official to expend and administer the**  
22 **budget, provided that any modifications or amendments shall be submitted for**  
23 **prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
25 **day of MAY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Sections 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**  
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
30 **Act of June 18, 1934 (48 Stat.984).**
