

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving May 2016 Legislative Rules Amendments Clarifying the Process
for Approving Legislative Council Minutes)

LEGISLATIVE ORDER NO. 16-182

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power to establish rules and procedures to regulate
3 all meetings of the Council and its standing committees (Constitution of the
4 Tohono O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Council has exercised this power by adopting and amending the
6 Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules");
7 and

8 **WHEREAS,** the Legislative Rules Committee recommends that the Legislative Council amend
9 Legislative Rules Article V, Section 2(B)(1), (D), and (E) and Article VIII, Section
10 2(A)(1) in accordance with the attached Legislative Rules amendments dated for
11 reference May 2016, which clarifies the process for approving Legislative Council
12 minutes.

13 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council adopts the
14 Legislative Rules amendments as dated for reference May 2016 to clarify the
15 process for approving Legislative Council minutes.

16 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04TH day of
17 MAY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST;
18 -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI,
19 Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
20 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian
21 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
22 Stat.984).
