

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sells District FY 2016 Budget from Initiative INT-01-14 Distribution
in the amount of \$126,260.07)

RESOLUTION NO. 16-201

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the Nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(3)); and

7 **WHEREAS,** Tohono O'odham Legislative Council did pass Resolution No. 15-275 for
8 "Dissolution of the Hia-ced District and Distributing Funds to Nation's Districts"
9 for an equal distribution to the Nation's eleven districts for an amount of
10 \$126,260.07; and

11 **WHEREAS,** the Hia-ced District funds of \$126,260.07 will be distributed between the four
12 communities at an amount of \$31,565.02 to Ge Oidag, Sells and North
13 Communities and \$31,565.01 to Cowlic Community; and

14 **WHEREAS,** the budgets have been approved by each community by Resolution No. CC-37-15
15 for Cowlic Community; Resolution No. GO-32-2016 for Ge Oidag Community;
16 Resolution No. NC-66-16 for North Communities and Resolution No. SC-097-16 for
17 Sells Community; and

18 **WHEREAS,** Sells District Council did approve the distribution of the Hia-ced District funds
19 for the Sells District Communities in the amount of \$31,565.02 to Ge Oidag, Sells
20 and North Communities and \$31,565.01 to Cowlic Community with Resolution No.
21 SD-44-16 as per the attached budgets; and

22 **WHEREAS,** the Budget and Finance Committee of the Tohono O'odham Legislative Council
23 has reviewed the budget and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 apportionment of the Hia-ced District funds in the amount of \$126,260.07 to Sells
26 District to be distributed to each of the four communities.

1 BE IT FURTHER RESOLVED the Hia-ced District funds of \$126,260.07 will be distributed between
2 the four communities at an amount of \$31,565.02 to Ge Oidag, Sells and North
3 Communities and \$31,565.01 to Cowlic Community.

4 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
5 Sells District Chairperson and any designated District Official to expend and
6 administer the budget as attached, provided that any modifications or
7 amendments affecting the funds or funding levels of the budget shall be
8 submitted for further prior approval by the Tohono O'odham Legislative Council.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
10 day of MAY, 2016 at a meeting at which a quorum was present with a vote of 2,792.8 FOR;-0-
11 AGAINST; -0- NOT VOTING; and 228.6[07] ABSENT, pursuant to the powers vested in the Council
12 by Article VI, Section (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
13 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat.984).
