

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District-West Villages Community FY2016 Budget Amendment No. 2)

RESOLUTION NO. 16-203

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 15-375**
8 **Approving Chukut Kuk District FY 2016 Budget; and**

9 **WHEREAS, Amendment No.1 to the Chukut Kuk District FY 2016 budget was approved by**
10 **Tohono O'odham Legislative Council Resolution No. 15-480; and**

11 **WHEREAS, Amendment No. 2 to the Chukut Kuk District FY 2016 budget was approved by**
12 **Tohono O'odham Legislative Council Resolution No. 16-020; and**

13 **WHEREAS, the Chukut Kuk District Council enacted Resolution No. 2016-14 approving West**
14 **Villages Community FY 2016 Budget Amendment No. 2 transferring funds in the**
15 **amount of \$5,383.34 to various line items to cover anticipated costs and**
16 **amending budget justification to Line Item 850-Food and Line Item 865-Other**
17 **Emergency; and**

18 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
19 **did review West Villages Community FY 2016 Budget Amendment No. 2 and**
20 **recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
22 **approves Chukut Kuk District-West Villages Community FY 2016 Budget**
23 **Amendment No. 2.**

24 **BE IT FURTHER RESOLVED that this amendment will include additional language to the budget**
25 **justifications to Line Item 850-Food and Line Item 865-Other Emergency.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **District Chairperson and any designated official to expend and administer the**
28 **budget as attached provided that any amendments affecting the funds or funding**
29 **level of the Chukut Kuk District FY 2016 Budget shall be submitted to the Tohono**
30 **O'odham Legislative Council for further prior approval.**


