13		September 30, 2016; and

15		approval its FY 2016 Child Care and Development Fund Mandatory Carry Forward
16		Budget which uses the FY 2015 carry forward amount of \$68,583.00; and
17	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
