

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2016 Child Care & Development Fund Mandatory Carry Forward Budget)**

**RESOLUTION NO. 16-206**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
8 **Families awarded the Tohono O'odham Nation the Child Care & Development**  
9 **Fund a grant for fiscal year 2015 to implement Child Care Services through the**  
10 **Division of Early Childhood Development; and**

11 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year**  
12 **2015 Carry Forward Mandatory Funds must be obligated and liquidated by**  
13 **September 30, 2016; and**

14 **WHEREAS, the Child Care Services Program has prepared and submitted for review and**  
15 **approval its FY 2016 Child Care and Development Fund Mandatory Carry Forward**  
16 **Budget which uses the FY 2015 carry forward amount of \$68,583.00; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
18 **reviewed the FY 2016 Child Care & Development Fund Mandatory Carry Forward**  
19 **Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2016 Child Care & Development Fund Mandatory Carry Forward Budget, which**  
22 **utilizes the FY 2015 carry forward amount of \$68,583.00.**


23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2016 Child Care & Development Fund Mandatory Budget provided**

27 **approval by the Tohono O'odham Legislative Council.**

7 18, 1934 (48 Stat.984).


