

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Child Care & Development Fund Discretionary Carry Forward Budget)

RESOLUTION NO. 16-207

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
8 **Families awarded the Tohono O'odham Nation Child Care & Development Fund**
9 **a grant for fiscal year 2015 to implement Child Care Services through the Division**
10 **of Early Childhood Development; and**

11 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which fiscal year 2015**
12 **carry forward funds must be obligated and liquidated by September 30, 2016; and**

13 **WHEREAS, the Child Care Services Program has prepared and submitted for review and**
14 **approval its FY 2016 Child Care & Development Fund Discretionary Carry**
15 **Forward Budget using the carry forward funds from fiscal year 2015 in the**
16 **amount of \$99,709.00; and**

17 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
18 **the Legislative Council have reviewed the FY 2016 Child Care & Development Fund**
19 **Discretionary Carry Forward Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2016 Child Care & Development Fund Discretionary Carry Forward Budget in**
22 **the amount of \$99,709.00, which shall be funded from carry forward funds from**
23 **Grant Year 2015.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2016 Child Care & Development Fund Carry Forward Budget as**
27 **attached, provided that any amendments or modifications shall be submitted for**
28 **further prior approval by the Tohono O'odham Legislative Council.**


