

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting the Tohono O'odham Nation Administrative Plan 2015-2019)**

**RESOLUTION NO. 16-210**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation, Article VII, Section 2(a) provides**  
2 **the Chairman with the power to oversee the administration and management of**  
3 **the government in accordance with an administrative plan adopted by the**  
4 **Tohono O'odham Legislative Council; and**


5 **WHEREAS, the Chairman of the Tohono O'odham Nation has submitted to the Legislative**  
6 **Council his Administrative Plan for developing and implementing projects**  
7 **through specific strategies that are linked to his Vision and Core Values; and**

8 **WHEREAS, the Administrative Plan was presented to the Legislative Council for review and**  
9 **consideration.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts the**  
11 **Tohono O'odham Nation Administrative Plan 2015-2019; provided that (1) any**  
12 **changes to the Plan or the organization chart in the Plan shall be submitted to**  
13 **the Legislative Council for prior approval and (2) any conflicts between the**  
14 **organization chart in the Plan and organization charts approved by resolution**  
15 **with executive branch budgets shall be governed by the charts approved with**  
16 **budgets.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>**  
18 **day of MAY, 2016 at a meeting at which a quorum was present with a vote of 1,590.55 FOR;**  
19 **1,430.85 AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**  
20 **Council by Article VII, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**  
21 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
22 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
23 **Act of June 18, 1934 (48 Stat.984).**


