

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 83-83, 131-84, 58-85, 303-88, 95-003,
99-039, 99-420, 2000-035, 01-496, 03-280, 04-291, 12-144, and 13-243 to Reflect
Legal Name Changes of Enrolled Members)**

RESOLUTION NO. 16-219

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
11 **O'odham Legislative Council shall determine whether an application is**
12 **approved for membership and its determination, along with the resolution**
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
15 **name changes of enrolled members due to a variety of reasons, such as**
16 **marriage, divorce, or legal adoption; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 83-83, 131-**
18 **84, 58-85, 303-88, 95-003, 99-039, 99-420, 2000-035, 01-496, 03-280, 04-291, 12-144,**
19 **and 13-243 be amended to reflect the amended names for the members**
20 **identified in the June 2016 Amended Enrollment Resolution Summary, which is**
21 **incorporated by this reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
23 **Resolution Nos. 83-83, 131-84, 58-85, 303-88, 95-003, 99-039, 99-420, 2000-035, 01-**
24 **496, 03-280, 04-291, 12-144, and 13-243 are amended upon the effective date of**
25 **those resolutions to reflect the legal name changes for the members identified**
26 **in the June 2016 Amended Enrollment Resolution Summary.**


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
28 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 219.9 [04] ABSENT, pursuant to the powers vested in the Council**
30 **by Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
31 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
32 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
33 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


