

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No.01-263, "Approving Enrollment or Adoption
Applications for Membership in the Tohono O'odham Nation for June 2001,"
to Delete Member who was Approved Twice)**

RESOLUTION NO. 16-221

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article VI,**
3 **Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**

4 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
5 **Enrollment Committee is responsible for reviewing enrollment applications**
6 **and making recommendations to the Legislative Council regarding the**
7 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
8 **and**

9 **WHEREAS, the Enrollment Program has determined that a member was originally**
10 **approved for membership by Resolution Nos. 99-621; and**

11 **WHEREAS, the Enrollment Program discovered that this same member was mistakenly**
12 **approved a second time for membership by Resolution No. 01-263; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 01-263 be**
14 **amended to delete the member identified in the attached Amending Enrollment**
15 **Resolution List June 2016; and**

16 **WHEREAS, the member that was originally approved in Resolution No. 99-621 will retain the**
17 **roll number and approval date identified in that resolution.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
19 **Resolution No. 01-263, "Approving Enrollment or Adoption Applications for**
20 **Membership in the Tohono O'odham Nation for June 2001," is amended upon**
21 **effective date of that resolution by deleting the member and corresponding**
22 **information identified in the attached Amending Enrollment Resolution List**
23 **June 2016.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
25 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 219.9 [04] ABSENT, pursuant to the powers vested in the Council**
27 **by Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
29 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
30 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
