13	WHEREAS,	the Enrollment Program therefore recommends that Resolution No. 01-263 be
14		amended to delete the member identified in the attached Amending Enrollment
15		Resolution List June 2016; and
16	WHEREAS,	the member that was originally approved in Resolution No. 99-621 will retain the
17		roll number and approval date identified in that resolution.
