

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Certification of A Tohono O'odham Nation Eligible Adult Member**  
**for the Third Per Capita Distribution for June 2016)**

**RESOLUTION NO. 16-225**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
3 **per capita payments to the Nation's members provided that sufficient gaming**  
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**  
7 **authorize per capita distribution payments in accordance with the Initiative**  
8 **(Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Revenue Allocation Plan pursuant to**  
10 **Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, on July 28, 2006, the Secretary of the Department of Interior approved the Third**  
12 **Revenue Allocation Plan; and**

13 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**  
14 **the Tohono O'odham Legislative Council the Master List for Eligible Adult**  
15 **Tohono O'odham Members for the Third Per Capita Distribution ("Master List")**  
16 **for review and approval; and**

17 **WHEREAS, Legislative Council approved the Master List with the initial number of 17,669**  
18 **verified adult members (Resolution Number 06-624); and**

19 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
20 **verification of a member and certification by the Tohono O'odham Legislative**  
21 **Council; and**

22 **WHEREAS, the Tohono O'odham Department of Membership Services has submitted a**  
23 **certification list of one verified adult member who is listed on the previously**  
24 **approved Master List and is eligible to receive the third per capita payment.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 26 **1. Approves the verification and certification of the adult member listed on**  
27 **the attached June 2016 Certification Listing of An Adult Member for the**  
28 **Third Per Capita Distribution.**



- 1                   2.       **Approves the distribution of \$2,000, less any applicable taxes required by**  
2   **federal law, to the adult member listed.**
- 3                   3.       **Authorizes the Chairperson of the Nation or a designated official to**  
4   **execute such other documents as may be necessary to implement this**  
5   **resolution.**


6       **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of**  
7   **funds to additional eligible Tohono O'odham adult members is contingent upon**  
8   **verification of membership by the Tohono O'odham Department of Membership**  
9   **Services and certification by the Tohono O'odham Legislative Council.**

10       **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
11       **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0-**  
12       **AGAINST; -0- NOT VOTING; and 219.9 [04] ABSENT, pursuant to the powers vested in the Council**  
13       **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
14       **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15       **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
16       **June 18, 1934 (48 Stat.984).**
