Indian Gaming Association/ATG2 Tribal Leaders Meeting)

LEGISLATIVE ORDER NO. 16-227

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to "by majority vote, call for a special session"**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**


9 **WHEREAS, Article I, Section 2(C) of the Legislative Rules, as amended, provides that "[a]ll**
10 **Legislative Council sessions shall be held at the Tohono O'odham Legislative**
11 **Council chambers located in Sells, Tohono O'odham Nation, with the following**
12 **exceptions. . . [a] majority of all the legislative representatives may vote to hold a**
13 **session in some location other than the chambers located at Sells."; and**

14 **WHEREAS, the Commerce Committee has requested a special session on June 17, 2016 at**
15 **Desert Diamond Sahuarita for the Arizona Indian Gaming Association/ATG2**
16 **Tribal Leaders meeting with roll call at 8:30 a.m.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
18 **special session on June 17, 2016 at Desert Diamond Sahuarita for the Arizona**
19 **Indian Gaming Association/ATG2 Tribal Leaders meeting with roll call at 8:30**
20 **a.m.**

21 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of**
22 **JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and 219.9 [05] ABSENT, pursuant to the powers vested in the Council by Article**
24 **VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
27 **(48 Stat.984).**
