

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Department of Health and Human Services, Division of Senior Services Title III Congregate Meals, Home Delivered Meals, Transportation, Outreach, Information & Referral and Training Budgets)**

RESOLUTION NO. 16-231

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** funding for the operation of the Senior Services Division is possible in part with
8 funding from Title III of the Older Americans Act through the Inter-Tribal
9 Council of Arizona; and

10 **WHEREAS,** the Senior Services Program has prepared and submitted its FY 2017 Title III
11 Budgets in the following amounts: C-1 Congregate Meals-\$43,724.00; C-2 Home
12 Delivered Meals-\$28,023.00; B Transportation-\$36,689.00; E Outreach-
13 \$10,000.00; Information & Referral-\$4,000.00; and Training-\$10,687.00 with a
14 project period of July 1, 2016 to June 30, 2017 with the FY 2017 salary amounts
15 adjusted effective October 1, 2016 to reflect the COLA increase in the amount of
16 2.16%; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed these budgets and recommend their approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 **FY 2017 Tohono O'odham Nation Department of Health and Human Services,**
21 **Division of Senior Services Title III Congregate Meals, Home Delivered Meals,**
22 **Transportation, Outreach, Information & Referral and Training Budgets.**

23 **BE IT FURTHER RESOLVED** that the FY 2017 Senior Services Title III will include C-1 Congregate
24 **Meals-\$43,724.00, C-2 Home Delivered Meals-\$28,023.00, B Transportation-**
25 **\$36,689.00, E Outreach-\$10,000.00, Information & Referral-\$4,000.00 and**
26 **Training-\$10,687.00 Budgets, in the total amount of \$133,123.00 for the period**
27 **July 1, 2016 to June 30, 2017 and to utilize the Nation's resources pending**
28 **reimbursement from the Grantor for continuation of this grant.**

4 Meals, C-2 Home Delivered Meals, B Transportation, E Outreach, Information &
5 Referral and Training budgets provided however, that any amendments or
6 modifications shall be submitted for prior approval by the Tohono O'odham
7 Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
9 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,595.7 FOR; -0-
10 AGAINST; -0- NOT VOTING; and 425.7 [06] ABSENT, pursuant to the powers vested in the Council
11 by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
12 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
14 Act of June 18, 1934 (48 Stat.984).


