

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Tohono O'odham Nation Department of Health and Human  
Services, Division of Senior Services Title VI-A-Grants for Native Americans, Title  
VI-C-Caregiver Support and Title VI Nutrition Services Incentive Program Budgets)**

**RESOLUTION NO. 16-232**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the funding for the operation of the Senior Services Division is possible in part**  
8 **with funding from Title VI of the Older Americans Act of 1978 as amended and**  
9 **administered by the Administration of Aging; and**

10 **WHEREAS, the Senior Services Division has prepared and submitted its FY 2017 Title VI**  
11 **Budgets in the following amounts: Title VI-A Grants for Native Americans-**  
12 **\$184,510.00; Title VI-Nutrition Services Incentive Program-\$2,432.00; and Title**  
13 **VI-C Caregivers Support-\$57,120.00 with a project period of April 1, 2016 to**  
14 **March 31, 2017 with the FY 2017 salary amounts adjusted effective October 1,**  
15 **2016 to reflect the COLA increase in the amount of 2.16%; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
17 **reviewed these budgets and recommend their approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2017 Tohono O'odham Nation Department of Health and Human Services,**  
20 **Division of Senior Services Title VI- A-Grants for Native Americans, Title VI- C-**  
21 **Caregiver Support and Title VI Nutrition Services Incentive Program Budgets.**

22 **BE IT FURTHER RESOLVED that the FY 2017 Senior Services Title VI budgets will include A-**  
23 **Grants for Native Americans-\$184,510.00, C-Caregivers Support-\$57,120.00 and**  
24 **Nutrition Services Incentive Program \$2,432.00 for a total amount of \$244,062.00**  
25 **for the period April 1, 2016 to March 31, 2017 and to utilize the Nation's**  
26 **resources pending reimbursement from the grantor for the continuation of the**  
27 **grant.**

2 O'odham Nation chairperson or any designated official is authorized to  
3 administer and expend the FY 2017 Senior Services Title VI-A Grants for Native  
4 Americans, Title VI-C Caregivers Support and Title VI Nutrition Services  
5 Incentive Program budgets provided however, that any amendments or  
6 modifications shall be submitted for prior approval by the Tohono O'odham  
7 Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>  
9 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0-  
10 AGAINST; -0- NOT VOTING; and 219.9 [05] ABSENT, pursuant to the powers vested in the Council  
11 by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted  
12 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
14 Act of June 18, 1934 (48 Stat.984).
